The tumors occurred along with irritation of the respiratory tract and the accumulation of a yellow material in the lungs. There was irritation only at 1.0 mg/m3 and no effect at 0.2 mg/m3. MDI is not listed as carcinogenic by the International Agency for Research on Cancer (IARC), the National Toxicology Program (NTP) or the Occupational Safety and Health Administration Continued on next page
